### Awards

## I Love My Librarian Award

#### Saundra Ross-Forrest

A love for reading, travel and service guided the steps of Saundra Ross-Forrest and led her to Birmingham and the Birmingham Public Library, North Avondale Branch. During her nine years as manager of the neighborhood library, she has worked tirelessly to make the branch an integral component of the North Avondale community. Today, that commitment has placed her in a prestigious position with nine other librarians from across the country. During a ceremony in New York, Ross-Forrest was named one of ten librarians to receive the Carnegie Corporation of New York/*New York Times*, I Love My Librarian Award for community service.

Ross-Forrest was recognized for going beyond the call of duty to develop outreach programs, foster innovative ideas for service and provide a friendly library setting that keeps regulars and newcomers walking through the doors. "While many people look at the North Avondale community as a place where children could be destined to a life of drugs, teenage pregnancy and poverty, Saundra has a different viewpoint. She sees the area as a place that can grow a garden full of successful professionals. To reap such a harvest, it depends on what you put into the soil. Saundra is using her library to plant seeds that are destined for greatness. She doesn't believe in the word, "No." She uses the power of "Yes" as fertilizer to make the community's garden something that will benefit everyone," said Gwendolyn B. Guster Welch who nominated Ross-Forrest for the award.

The award encourages library users to recognize the accomplishments of exceptional public, school, college, community college and university librarians. It carries with it a \$5,000 cash award, a plaque and a travel stipend to attend the awards reception hosted by *The New York Times*. The award is supported by Carnegie Corporation of New York and The New York Times and administered by ALA, the oldest and largest library association in the world, and The Campaign for America's Libraries, ALA's public awareness campaign about the value of libraries and librarians.

## **Legislative Update**

It may be a new year but, on the federal legislative front, there are still some important bills left over from 2011 that have not seen further action. For more details, see the December 2011 Legislative Update column but I will note the current status of these bills as of January 20, 2012.

Relating to copyright and the possible criminal prosecution of libraries are H.R. 3261, the Stop Online Piracy Act (SOPA) which is also known as the Enforcing and Protecting American Rights Against Sites Intent on Theft and Exploitation (E-PARASITE) Act, and S. 968, the Preventing Real Online Threats to Economic Creativity and Theft of Intellectual Property Act of 2011 (PROTECT IP Act of 2011). The last Congressional action on the former was on December 15 and 16 when committee (the House Committee on the Judiciary) consideration and mark-up sessions were held (in other words final revisions were being made to the text) and on December 17 the latter bill a motion was made to consider the bill in the Senate, however, a cloture motion was made as well, meaning that S. 968 is, for now, still bottled up in the Senate Committee on the Judiciary.

Inaction continues to be the story concerning the SKILLS (Strengthening Kids' Interest in Learning and Libraries) Act which was introduced into the Senate by Senator Jack Reed (Rhode Island) on July 6, 2011. The bill was on that date read twice and referred to the Senate Committee on Health, Education, Labor, and Pensions where it has languished ever since.

On a related and disturbing note Representative Darrell E. Issa (Republican - California) introduced the Research Works Act (H.R. 3699) into the House of Representatives on December 16. The bill was referred to the House Committee on Oversight and Government Reform. This bill, which received enthusiastic support from the Association of American Publishers, represents a threat to open access for online scholarship and publishing. Quoting directly from the January 6, 2012 update of the *ACRLog*, "The Research Works Act will prohibit federal agencies from unauthorized free public dissemination of journal articles that report on research which, to some degree, has been federally-funded but is produced and published by private sector publishers receiving no such funding. It would also prevent non-government authors from being required to agree to such free distribution of these works. Additionally, it would preempt federal agencies' planned funding, development and back-office administration of their own electronic repositories for such works, which would duplicate existing copyright-protected systems and unfairly compete with established university, society and commercial publishers."

The Alabama Legislature will begin its 2012 Regular Session on February 7. As always, we need to monitor activities on the state level, particularly in regard to funding for the Alabama Virtual Library (AVL). Recent news reports indicate that Governor Robert Bentley has an interest in merging the Education Trust Fund with the General Fund budget for the purpose of transferring some funds out of Education into other areas of the budget suffering funding shortfalls thanks to the poor economy and lower tax revenue received. This is potentially bad news for everyone in the field of education including librarians not to mention bad news for the students of Alabama attending public schools, colleges, and universities.

# Troy University Dothan

Olga Casey never planned to become a U.S. citizen when she arrived from the Ukraine in 2000.

"I came as a student," she said. "I was more worried how I'm going to study in English. I didn't think more than two years ahead. I just wanted to get my degree."

Things changed, however, when she married Al Casey of Slocomb. The two had been communicating by computer since 1998, having met online in a chat room. They married in 2001 and started the journey of ensuring Olga's legal status as an American citizen.

It took 10 years, but last week Olga Casey, 46, swore an oath to the United States of America and became a naturalized citizen.

"I was very excited, very excited," she said. "I wanted it long ago."

Colleagues and friends at Troy University's Dothan campus surprised her Thursday with a reception.

Her original plan more than 10 years ago was to finish her master's degree in library and information sciences at LSU, where she was studying under an international fellowship. She was to be in the United States for two years and under the terms of her student visa would be required to return to the Ukraine for two years after completing her studies. But Al proposed and the two were married in March 2001. Olga spent the following summer interning at Houston-Love Memorial Library in Dothan.

Olga returned to the Ukraine in 2002, and Al traveled to the Ukraine every six months. They didn't want Olga to visit the U.S. because any time here would have counted against her required two years back in the Ukraine.

Two years later, she returned on a spouse visa. Then, it was just a matter of waiting. Four years to get her green card. Another three years before she could apply for citizenship. There was paperwork to be filled out and trips to Birmingham for fingerprinting and biometrics testing.

"If it doesn't kill you, it makes you stronger is basically the way I look at it," said Al Casey.

When she got her green card in 2008, she immediately applied for a position at Troy University's Dothan campus. She was hired as the technical services librarian.

In July of this year, she formally applied for citizenship. She went to Atlanta to take a civics and history exam and have a final interview.

Within a couple of days, she received her invitation to return to Atlanta and take her oath.

And on Dec. 2, Olga Casey joined about 160 people to become the newest U.S. citizens.

"We woke up the second morning and she said, 'You know, Americans sleep a lot better than Ukrainians," Al Casey said. "I was really proud and relieved, too, that this process we started doing in 2000 was completely over with."
